Priyadarshni Academy offers its hand to BMC in creating citizen awareness at a meeting hosted by IMC, Academy, and 100 NGOs

Municipal Commissioner **Mr. Swadheen Kshatriya** of the Municipal Corporation of Greater Mumbai (MCGM) addressed an interactive meeting on "The Problems of Water Supply and Cleanliness" on February 17 at the Walchand Hirachand Hall of the IMC. The meeting was organized by IMC, Priyadarshni Academy, Rotary Club of Bombay, Property Owners Association, Nepean Sea Road Citizens' Forum, and 100 other prominent NGOs. **Mr. R. A. Rajeev**, Additional Municipal Commissioner (Conservancy & Waste Management) addressed the meeting on "Solid Waste Management".

Mr. Nanik Rupani of IMC's Mumbai Development Committee introduced the theme. He said that the water supply situation facing the city is grave and that the corporate sector and the NGOs have to work shoulder-to-shoulder with MCGM to resolve the problem.

IMC President **Mr. Gul Kripalani**, who welcomed the distinguished speakers and the gathering, said that Maharashtra was

paying a heavy price for its high degree of industrialization and urbanization. The pressures created by the demands of building infrastructure for the growing population were having a severe impact on the environment, particularly evident in the deteriorating quality of its water. Many localities of the city of 18 million inhabitants receive water only a few hours a day, forcing residents to buy water at exorbitant prices from touts or water tank owners. **Mr. Kshatriya** cautioned that Mumbai's growing water shortage is a potentially dangerous trigger for nationwide social unrest.

Mr. Kshatriya began by saying that Mumbai metropolitan region received much less potable water

supply than the average in many previous years, due to scanty rainfall. In view of this, MCGM will not be able to increase the daily water supply to the city in excess of 2,900 million liters till July 15. When the catchment areas of these reservoirs received less rainfall due to failure of monsoon, the city is left with few options.

About 20% to 25 % of the water supply is leaked away or pilfered along the pipelines. A substantial portion of the potable water supplied to the city is being recklessly used and wasted for washing vehicles, flushing toilets, watering gardens and for industrial purposes. **Mr. Kshatriya**

suggested that heavy users such as Railways, Bombay Port Trust, and BEST should think of recycling water. Possibilities will have to be explored for repairing old bore wells and ponds, and replacing old pipelines. He also stated that BMC is not able to reach the fag-end areas or those on high elevation. There are severe problems for localities on hilly terrain. Supply can be augmented with bore wells and

tankers.

The MCGM has now planned to augment water supplies by implementing additional reservoir projects -- Middle Vaitarna (455 mld), Gargai (455 mld) and Pinjal (868 mld). "In addition, we are also setting up large water recycling facilities in public-private partnership (PPP) mode in Ghatkopar, Mulund, Versova and Colaba for processing waste and grey water, now flowing into the sea. The Commissioner observed that "Singapore authorities do not allow a single drop of water to go into the sea. On the successful model of the desalination plant set up by Chennai Petroleum Corporation, we are also planning to set up similar projects in Mumbai."



"MCGM has already taken some steps towards harvesting rainwater, and economic use of water by cooperative housing societies and others. All these measures will be able to provide sufficient water to Mumbai city in the next quarter century," he said.

Mr. R A Rajeev spoke on "Solid Waste Management" and described at length the various measures being implemented by MCGM for creating a clean environment in the city. MCGM's department is required to clear every day about 6,000 tons of domestic garbage and 2,400 tons of construction debris from various localities and process them by way of aerobic composting, RDF and biodegeneration at the dumping and landfill sites at Gorai, Mulund, and Deonar -- all on a PPP basis. As the Gorai site has reached its optimum capacity, the MCGM implemented a project for reclaiming the ecological balance and beautification of the site at a cost of Rs.50 crore. "Now we are generating 1,000 cubic metres of methane (greenhouse gas) from the site and generating 3MW of electricity. In addition, we have earned carbon credit to the tune of over Rs.74 crore" **Mr. Rajeev** said.

He also cited that BMC is in talks with a US-based multinational, General Electric, for acquiring technology to

convert methane generated through waste into energy. Methane is considered to be 21 times more harmful than carbon dioxide.

Mrs. Bakul Patel, Chairperson of Priyadarshni Academy's Forum for Environment Protection, urged MCGM to encourage the cooperative housing societies in the city to set up rainwater harvesting projects, to stop the use of potable water for construction of buildings, and also to prevent the water tanker mafia from fleecing citizens. Participation with corporations will work wonders. MCGM should take action against people who make unauthorized use of water. **Mr. Neelu Gidwani**, General Secretary of Nepean Sea Road Citizens' Forum, urged MCGM to provide better conservation services to the slum dwellers "who constitute 60% of the population of the locality." Rotarian Nandan Damani sought MCGM's active cooperation with Rotary Club of Bombay in its campaign of creating public awareness on the need to use potable water more rationally. **Mr. Niranjan Hiranandani** said that builders should be encouraged to construct eco-friendly "green houses" and to undertake rain harvesting in a big way.

Priyadarshni Academy assures support to E-Waste removal initiatives and to improve citizen health

CLEAN-Sweep Forum (CSF), supported by Nariman Point Association (NPA), organised a presentation on E-waste and its management on January 4, 2010 at the Kamalnayan Bajaj Hall at Nariman Point to bring about awareness in the business district as e-waste is generated in big quantities in that area.

The Chief Guest, **Mrs. Valsa Nair Singh**, Principal Secretary of Environment of the Government of Maharashtra, appreciated CSF for its efforts and also announced her support by keeping e-waste bins in Mantralaya at various places. She also confirmed that CSF's project to distribute e-waste bins in colleges will be sponsored by Maharashtra Pollution Control Board-MPCB. She suggested that a specific day per month should be fixed for the students to deposit E-waste items in the E-waste bins. She acknowledged the ECO-RECO for the facility that they have built to treat e-waste.

The Guest of Honour, Rotarian **Nanik Rupani**, assured his full support to the project and stated that he will incorporate it in Priyadarshni Academy's agenda of activities.

It is estimated that over 400,000 tons of e-waste is generated in our country per annum. According to Maharashtra Pollution Control Board (MPCB)'s assessment, Mumbai alone generates over 12,000 tons. However, the hazards of e-waste are caused mainly by the manner in which it is discarded and disposed off.

A proper recycling unit at your doorstep is available in Mumbai-ECO-RECO which collects e-waste from offices and recycles it with proper technology. An E-waste bin is also available to collect e-waste in the premises which will be implemented by ECO-RECO.

Mr. B.K. SONI of ECO-RECO gave information by explaining the process in which e-waste is treated.

The Rotary Club of Bombay-GREEN VISION Committee was a co-supporter of this event. Rotarian & former IMC President, **Mr. Shailesh Haribhakti** stated that he will convince offices in Free Press House at Nariman Point and his own office to use the e-waste bin.

Mr. Maurice Martinez of Alliance Francaise appreciated the efforts of CSF as the message of Bonjour India festival is to protect the environment.

The Rotaractors of H.R. College showed tremendous interest as they got a lot of information on E-waste which will be put to use to help CSF activities.

Mr. Rajkumar Sharma, Convenor, CSF, concluded with the following statement. "It is extremely necessary to frame rules and regulations to treat e-waste apart from the guidelines already existing, as facilities are available now, e.g., ECO-RECO and others". He suggested the immediate cessation of the dumping of E-Waste and other wastes by some countries on India and to involve the informal sector by making it a collector of e-waste all over the city.

In the lucky draws for e-waste bins sponsored by ECO-RECO, EARNEST HOUSE and SAKHAR BHAVAN Buildings, members of the Nariman Point Association, were lucky winners.



Arthashastra and economic meltdown

Chairman **Mr. Nanik Rupani** gave the welcome address at the half-day seminar on 'WTO Agreements and Doha Negotiations: Towards Capacity Building of Stakeholders' during which he spoke strongly of the need for political and economic leaders to adopt the principles laid down in **Kautilya's 'Arthashastra'**. This, he said, would help economic governance and prevent the kind of debacle the world has been facing because of the meltdown and accelerate a safe uptrend. The half-day seminar was held at the Sunville Banquet and Conference Halls in Mumbai on December 15, 2009 and was jointly organized by Dept. of Commerce, GOI, Centre for WTO Studies, and FICCI. The program was well attended by about 200 influential leaders.

Former global awardee, Dr. Hari Harilela, receives Hong Kong's highest award

Dr. Hari N. Harilela, received Hong Kong's highest award, the Grand Bauhinia Medal (GBM) on October 17, 2009. Dr. Harilela is the only Indian to be honored with this exceptionally high distinction. It is in fact the first ever highest honor bestowed on an overseas Indian by a foreign government. Honourable Donald Tsang presented the award.

The award was in recognition of his distinguished record of public service, particularly for contributions to Hong Kong's economy, and exemplary community service to members of the Indian as well as the other ethnic minority groups. The Indian diaspora, numbering over 25 million, comprising both people of Indian origin and non-resident Indians, have made their mark across the globe in every walk of life. They are probably the most accomplished and educated minority group in various countries. In the book, '100 Global Indians', publishers of 'The Indian' have identified 100 Indians out of this vast population as the top 'Global Indian Entrepreneurs and Achievers'. Dr. Harilela is one of them.

A strong believer in supporting educational causes, Dr. Harilela made a donation of HK\$5 million to the Baptist University of Hong Kong in 2005 towards its development. In February 2008, he donated another \$5 million to the University for the establishment of the Padma and Hari Harilela Scholarship Fund for outstanding students. In recognition of their generous support, the University named two Lecture Theatres entitled 'Padma & Hari Harilela Lecture Theatres', to be used for holding seminars, public lectures and international conferences.

Dr. Harilela has received numerous prestigious awards during his life. He was ranked as one of the 20 most power people who really ran Hong Kong during the 1990's. He is the undisputed leader of Hong Kong's Indian community and the head of the Harilela clan.

Asia Magazine named him as one of the 24 people known as 'The Prime Movers' that comprised technicians, professionals, legislative council members and other prominent people. They helped Hong Kong to be called as 'The Modern Miracle'.

Born in 1922 in India and raised in Hong Kong, Dr. Harilela is a legendary figure who has worked his way up the social ladder through hard work and determination. Dr. Harilela's famous sayings are: "The Secret of Happiness is Freedom, and the Secret of Freedom is Courage"; "We must give back to our country not by just giving money, but by getting involved in the community". For his contributions to society, Dr. Harilela was honored, among others, with:

- Justice of the Peace, 1963
- Officer of the Most Excellent Order of the British Empire (OBE)
- Pravasi Bharatiya Samman Puraskar Award, Govt. of India, January 2003
- International Humanitarianism Award by the Anti Defamation League (given to Presidents of countries), October 24, 1985
- Hind Rattan Award by NRI Welfare Society of India, New Delhi, July 15, 1993
- Global Award for Outstanding Contribution to Corporate Social Responsibility by Priyadarshni Academy, September 19, 1998

Yesterday I have seen the News letter of Priyadarshani Academy. 'Rainbow'. Your activities are many fold and going through the Rainbow I was greatly impressed by it.

'Kautilya's Arthashastra' which you have printed is a great service you have done to the Indian culture, Economics and Politics. From childhood we have been told about Kautilya's Arthashastra by the senior members of my family. As you probably know the Walchand family is not only religious but also culturally very sound. Kautilya's Arthashastra was one of the very important aspects of our learning since it is mentioned in our Shastras also.

Kautilya has a prominent place in Jain Scriptures. He was advisor to Samrat Chandragupta Maurya, who was a Jain King. As you probably know King Ashok, grandson of Chandragupta was Jain but later converted into Buddhist religion.
